



2018 PROVIDER ATTESTATION OF THE FRAUD, WASTE AND ABUSE AND COMPLIANCE TRAINING

HealthSun Health Plans requires of all its providers to satisfy the FWA and Compliance Training and education requirements. As such, HealthSun requires that our Providers attest that they and their staff have been trained. It is recommended that the training documentation of each individual be kept on site and that the attestation be sent to the Provider Relations Department at HealthSun. The attestation(s) will be saved on file with the Compliance Department at HealthSun.

In order to ensure consistency and reduce burden on providers, suppliers, contractors and organizations, CMS developed a web-based training module that may be used to satisfy the FWA and Compliance Training and education requirements. We encourage the following staff members to take the Compliance and FWA training:

- 1) The Physician(s) or any other licensed medical or clinical personnel
- 2) Senior administrators or managers
- 3) Individuals involved with decision-making authority

The training must occur within 90 days of initial hiring and annually thereafter. The annual training can be completed any time between January 1 through December 31 of any given contract year. The Certificate will be downloaded and kept at your office and a copy will be sent to the HSHP Provider Relations Department.
